I, Nathaniel J. Wood, hereby declare:


1. I am a partner at Crowell & Moring LLP, counsel of record for The Regents in the above-captioned matter. The matters stated in this declaration are based on my personal knowledge and are, to the best of my knowledge, true. If called upon to do so, I could and would competently testify thereto. I offer this declaration in support of the Motion for Final Approval of the Class Action Settlement.

2. Pursuant to the terms of the settlement agreement, The Regents agreed to post a notice on the UCLA Health website providing a link to the Settlement Website from March 15, 2019 until May 20, 2019, and from June 21, 2019 until July 21, 2019. See Stipulation of Settlement § 5.2.5.

3. The Parties met and conferred and reached an agreement regarding the form, content and placement of the notice on the UCLA Health website.

4. On March 15, 2019, UCLA Health posted the notice on its website at www.uclahealth.org in the “News” section on the Home Page. Per the terms of the notice plan and the Stipulation of Settlement, it will remain live until May 20, 2019, and then be posted again from June 21, 2019-July 21, 2019 (assuming final approval is granted).
